

**REGISTER OF COUNCILLORS INTERESTS**

As a Member<sup>1</sup> of Royal Sutton Coldfield Town Council (“the Council”) you are required to register certain interests (known as “disclosable pecuniary interests”) of your own and of your partner<sup>2</sup>. These interests are set out in the table below.

When you are present at a meeting of the Council and you have a disclosable pecuniary interest (**which includes your own interest and that of your partner**) in any matter being considered which is entered in the Council’s register of interests, you do not need to disclose it to the meeting, but you will withdraw from the meeting room when the matter is being discussed and will not participate, or participate further, in any discussion of, or any vote taken on, the matter at the meeting.

If your disclosable pecuniary interest (**which includes your own interest and that of your partner**) is not entered in the Council’s register of interests, you will disclose its existence and, unless it is a sensitive interest<sup>3</sup>, its nature, to the meeting and will notify the Monitoring Officer of the interest within 28 days of the meeting. You will withdraw from the meeting room when the matter is being discussed and will not participate, or participate further, in any discussion of, or any vote taken on, the matter at the meeting.

<p><b>Employment, office, trade, profession or vocation:</b> Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner.</p>	
<p><b>Sponsorship</b> Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period<sup>4</sup> in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses.</p>	<p><u>Conservative Association</u> <u>(Sutton Coldfield)</u> .</p>

<sup>1</sup> “member” means a member of the Council and includes a co-opted member;

<sup>2</sup> Partner includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner

<sup>3</sup> An interest is sensitive if its nature is such that you, and your Monitoring Officer, consider that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation.

<sup>4</sup> “relevant period” means the period of 12 months ending with the day on which you give a notification of its existence

<p>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>	
<p><b>Contracts</b> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest<sup>5</sup>) and the Council; (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p>	<p>REDACTED</p>
<p><b>Land</b> Any beneficial interest in land<sup>6</sup> which is within the area of the Council.</p>	
<p><b>Licences</b> Any licence (alone or jointly with others) to occupy land in the area of the Council for a month or longer.</p>	
<p><b>Corporate tenancies</b> Any tenancy where (to your knowledge); (a) the landlord is the Council; and (b) the tenant is a body in which you or your partner has a beneficial interest.</p>	
<p><b>Securities</b> Any beneficial interest in securities<sup>7</sup> of a body where; (a) that body (to your knowledge) has a place of business or land in the area of the Council; and (b) either;  (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p>	

<sup>5</sup> “body in which the relevant person has a beneficial interest” means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and “director” includes a member of the committee of management of an industrial and provident society

<sup>6</sup> “land” excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

<sup>7</sup> “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
